- (b) The total number of employees who have either left or were removed from service in March/April, 77 was 218. Of these 218 workers, 2 persons belong to Amethi and none from Rai Bareli in Uttar Pradesh.
- (c) The termination of services of a large number of persons indicates the possibility of closure of the Factory in the near future.
- (d) The Government of Haryana, which is the appropriate Government under the Industrial Dispute Act in respect of this establishment, have referred for adjudication the industrial disputes regarding discharge of 37 workers who had made specific representations in this regard.
- (e) The Government of Haryana have been requested to examine the alleged violations of labour laws by the management of the Company, and to take appropriate action in the matter.]
