Contract for raw saltpetre at Hanumangarh

THE MINISTER OF STEEL AND MINES (SHRI BIJU PATNAIK) : (a) and (b) Saltpetre is one of the minerals not governed by the Mineral Concession Rules, 1960 but by the Minor Mineral Concession Rules of the concerned State Government.

Rule 20 of the Rajasthan Minor Mineral Concession Rules, 1959, provides that minor minerals may be leased out by

No, Sir. The Detailed Project Report has been received only recently and is under scrutiny by Steel Authori'v of India Limited. . . .

(b) 7,367 acres of land out of total of 9,021 acres required for the plant have been acquired. The rest of the land is Government land. Preliminary action for acquisition of land for the township has been taken. Works relating to raw material investigations, Topographical Surveys, Geophysical investigations. Preliminary water supply and power supply schemes by the State Government authorities have been completed.

(c) The date by which the plant is likely to be commissioned will be known only after the Detailed Project Report has been scrutinised and approved by the Government of India.
