(b) the items of import and export trade with Pakistan which have been exclusively reserved for the public sector?

THE MINISTER OF COMMERCE AND CIVIL SUPPLIES AND COOPERATION (SHRI MOHAN DHARIA) : (a) The following are the major items which are being exported from India to Pakistan: (i) ACER Conductors

(ii) Timber

(iii) Fresh Ginger

(iv) Betel leaves

(v) Bamboos

(vi) Resin and Rosin

(vii) Fluorescent tube/lamp/bulb and electrical goods

(viii) Rayon Yarn

(ix) Bleaching powder

(x) Bidi leaves

(xi) Tea

(xii) Coir yarn & Coir mats

(xiii) Iron and Steel items

(xiv) Coal

Major item of import from Pakistan to India is Raw cotton.

(b) Of the items mentioned in reply to part (a), export of coal and iron and steel items is canalised through Public Sector. A list of all items whose exports are canalised through Public Sector is in Annexure I to Section II of Export Trade Control Hand Book of Policy and Procedure 1977-78. Import of raw cotton from all countries (including Pakistan) is canalised through Public Sector. A list of all items whose imports are canalised through Public Sector is in Section III of the Import Trade Control Policy Volume I. 1977-78.
