- (b) whether there was any Short fall in the production of cotton in these years as compared to the pro duction in the preceding year; if so,, what are the reasons therefor?]

कृषि ग्रौर सिंचाई मंत्री (श्री सुरजीत सिंह बरनाला): (क) तथा (ख) 1975-76 में महाराष्ट्र में कपास का उत्पादन, 1974-75 में 17.17 लाख गांठों के रिकार्ड उत्पादन की तुलना में. लगभग 7.81 लाख गांठे था। 1975-76 में अंकरण के समय अधिक वर्षा होने के कारण फसलों को क्षति पहुंची थी। ग्रमी 1976-77 के विषय में महाराष्ट्र सरकार से उत्पादन के पक्के ग्रनुमान उपलब्ध नहीं हुए हैं। तथापि सितम्बर-अक्तूबर, 1976 में कुछ क्षेत्रों में लम्बे समय तक मुखा पड़ने के कारण इस वर्ष भी फसल को हानि पहंची है।

fITHE MINISTER OF AGRICULTURE AND IRRIGATION (SHRI SURJIT SINGH BARN ALA): (a) and (b) The production of cotton in Maharashtra during 1975-76 was estimated at 7.81 lakh bales as against the record level of 17.17 lakh bales in 1974-75. The crop in 1975-76 was damaged by excessive rains at the time of ball formation. Firm estimate of production for the year 1976-77 has not yet become available from Maharashtra. However, the crop in this year too was damaged by prolonged dry spell in some areas during September-October, 1976.]

## Scheme for giving grants to Scientists

- (a) whether it is a fact that the University Grants Commission has approved a scheme for giving grants to young Scientists to enable them to devote their whole time to research and study; and
- (b) if so, what are the details of the scheme?

THE MINISTER OF EDUCATION SOCIAL WELFARE AND CULTURE (DR. PRATAP CHANDRA CHUNDER): (a) and (b) Yes, Sir. According to the information furnished by the University Grants Commission, the Commission has instituted a scheme of "Career Awards" to enable young scientists to devote their whole time attention to research and study. Under this scheme, young talented scientists in the universities with established competence and good potential in their area of specialization, are offered these awards ordinarily for a period of three years. Lecturers/Readers who are not more than 35 years of age and have completed doctoral/post-doctoral or equivalent professional training are eligible for these awards. During the period of these awards, the Commission . will pay them full salary and allowances and in addition provide a research grant of upto Rs. 1,00,000/-and 2 or 3 Research Fellows. Selections for these awards are made on the recommendations of a Standing Committee constituted for the purpose.
