(b) if so, whether Government propose to invite the Ramayana ballet troupe from Bali Island to visit India?]

#### Import of Foodgrains

Will the Minister of AGRICULTURE AND IRRIGATION be pleased to state:

(a) whether Government propose to import foodgrains during the current year;

(b) if so, what is the quantum of foodgrains proposed to be imported; and

(c) what are the names of the countries with which negotiations are being held in this regard?

THE MINISTER OF AGRICULTURE AND IRRIGATION (SHRI SURJIT SINGH BARNALA): (a) to (c) In the context of the comfortable stock position. Government do not intend to import foodgrains during the current year. However, about 1.8 lakh tonnes of aid wheat from EEC and Belgium against their 1975-76 Food Aid Programme which could not be supplied last year, is expected to be shipped and received during the current year.

#### Scheme for giving Financial Assistance to Allottees of Surplus Statement

\*229. SHRI S. KUMARAN: Will the Minister of AGRICULTURE AND IRRIGATION be pleased to state:

(a) whether the Kerala Government have forwarded to the Central Gov-

ernment any scheme, for granting financial assistance to the hutment dwellers and recipients of surplus land in the State for improving their agricultural land; and

(b) if so, what is Central Government's decision thereon?

THE MINISTER OF AGRICULTURE AND IRRIGATION (SHRI SURJIT SINGH BARNAIA): (a.) and (b) A statement is laid on the Table of the Sabha.

#### Statement

Kerala Government requested the Government of India in September, 1975 for the grant of a special assistance of Rs. 13.24 crores for the years 1975-76 and 1976-77 for varices land reforms programmes. The Government of India drew the State Government's attention to the provision of an advance Plan assistance to the tune of Rs. 3.38 crores given to the State to meet the gap in its resources and to the decision to allow the State Government to carry over the deficit of Rs. 6.30 crores into the next financial year, *i.e.* 1976-77. The Government of India pointed out that if the State's demand for special assistance was to be accepted, the Government of India would have to meet similar demands from other States too and, therefore, suggested that the State Government, might consider re-ordering its Plan priorities so as to provide for land reforms measures necessary funds from within the approved Plan outlay and also to locate savings if possible, from non-Plan items.

2. Subsequent proposals for further assistance have been taken into consideration in the usual course for the determination of the size Of the annual plan of the State. Thus, provision of funds for land reforms has, as usual, been made in the annual plan of the State for the year 1977-78.

#### Export of Foodgrains

(a) whether it is a fact that Government have decided to export foodgrains;

(b) if so, what are the reasons therefor; and

(c) what is the quantity and value of foodgrains proposed to be exported during the current year?

THE MINISTER OF AGRICULTURE AND IRRIGATION (SHRI SURJIT SINGH BARNALA): (a) to (c) The Government have so far not taken any decision regarding the export of foodgrains and the whole matter is under examination. However, as in the previous years, export of limited quantities of superior bas-mati rice has been allowed to be continued during the current year.

#### Reduction in the Prices of DDA Flats
