more teachers particularly women teachers and opening more schools.

- (iv) Measures for reducing wastage and stagnation including massive orientation of primary teachers towards the techniques of universalisation of primary education, relating education to community development, fostering community participation in primary education, mak. ing primary school curriculum more enriched and interesting for the nonattending children and similar other measures.
- (v) Introduction of ungraded school system at this stage and massive adoption of non-formal methods of education ensuring multiple entry and part-time education.

By the end of the Fifth Five-Year Plan 96 per cent and 46 per cent of the children of the age-group 6-11 and 11-14 respectively are exepected to be covered. In addition it is proposed to provide facilities in nonformal education for children of the age-group 9-14. The present Government has under consideration preparation of a time-bound plan of action for universalisation of primary education.

### Acute Shortage of Ammonium Sulphate

- 513. SHRI GOVINDRAO CHANDRA MHAISEKAR: Will the Minister of AGRICULTURE IRRIGATION be pleased to state:
- (a) whether Government are aware that State Governments are facing difficulties in the distribution of ammonium sulphate on account of inadequate supply of the fertilizer to the States: and
- (b) if so, what steps Government propose to take to improve the supply position of the fertilizer?

THE MINISTER OF AGRICUL-(SHRI TURE AND IRRIGATION SURJIT SINGH BARNALA): and (b) Government are aware that due to historical and other reasons certains farmers still retain preference of Ammonium Sulphate (with 21 per cent N) over the comparati-

vely more recent product Urea (with 45 to 46 per cent N), even though the latter is cheaper per unit of nitrogen content, and is half as bulky therefore, cheaper to transport. Barring certain special crops or conditions, the economy and ciency of Urea compares favourably with Ammonium sulphate as a source of nitrogen. Efforts are, therefore, Ammonium being made to supply agronomi-Sulphate wherever it is cally recommended and to wean away the farmers from the use of Ammonium Sulphate and to educate them about the cost and efficiency of Urea for which there is no shortage in the country.

# Non-availability of Loans to New Allottees of Surplus land

- RAM-514. SHRI GOVINDRAO CHANDRA MHAISEKAR: Will Minister of AGRICULTURE IRRIGATION be pleased to state:
- Government (a) whether aware that due to the reluctance financial institutions in advancing loans, the new allottees of surplus land in various States have not been able to utilize development assistance rendered to them;
- (b) if so, whether Government propose to permit the State Governments to divert a part of the development assistance for utilisation as assistance to help the allottees; and
- (c) whether Government propose to continue crop assistance and development assistance to non-allottees of surplus land during the current year?

THE MINISTER OF AGRICUL-TURE AND IRRIGATION (SHRI SURJIT SINGH BARNALA): (a) and (b) Credit from co-operative institutions and commercial banks is available for agriculture. The Reserve Bank of India has issued instructions that 20 per cent of the short-term credit should be earmarked for small farmers. The new allottees of surplus land will benefit from this directive since they come under the category

In order that these cultivators in areas not covered by special schemes like the Command Prone Areas Programme, Area Development Programme Small and Marginal Farmers and Agricultural Labourers Development Agencies are not inconvenienced for want of wherewithals for cultivation, the Union Government makes available funds to State Governments for providing financial assistance to allottees of surplus land (i) for meeting their immediate requirements seeds, manures, fertilizers, pesticides and implements as well as consumption needs, and (ii) for undertaking essential land development measures.

(c) Schemes of providing ance to the small and marginal farmers who are non-allottees of surplus land would continue during the current year also.

### Shifting of Government Employees from Gole Market Area, New Delhi

- (c) if so, whether Government propose to defer the shifting of Government employees till the review completed?

THE MINISTER OF WORKS AND HOUSING AND SUPPLY AND RE-HABILITATION (SHRI SIKANDAR BAKHT): (a) The entire Gole Market area is to be redeveloped and the old quarters there, which
