Statement

The State Government had proposed an outlay of Rs. 246 lakhs for urban development in the State's Annual Plan proposal for 1977-78, and after discussions, the Planning Commission had approved an outlay of Rs. 230 lakhs, leaving the break-up to the discretion of the State Government. This outlay includes an earmarked outlay of Rs. 74 lakhs for environmental improvement of slums which is part of the Minimum Needs Programme.

In addition, the State Government has sent proposals for assistance under the Integrated City Development Programme for Hyderabad and Visakhapatnam urban areas and for taking up projects for the Hyderabad-Secunderabad city under the Six Point Formula Their Programme. request is for central assistance to support a total programme of Rs. 577.70 lakhs for Hyderabad-Secunderabad city and Rs. 207.84 lakhs for Visakhapatnam.
