Stopping of publication of Small Newspapers by Government

- (b) if so, what are the names of such newspapers and for what reasons their publication was stopped, and
- (c) whether Government propose to give them any assistance, by way of advertisements and loans, in order to make them viable again?

THE MINISTER OF INFORMATION AND BROADCASTING (SHRI LAL K. ADVANI): (a) and (b) Information is being collected from the State Governments | Union Territories and will be laid on the Table of the House

(c) Advertisements are released to meet varying publicity requirements and not as a measure of financial assistance. Within this framework and subject to the availability of funds, greater emphasis is laid on use of small medium newspapers particularly those published in Indian languages. There is no scheme for granting them any assistance in the form of loan.
