#### Curfew in Dimapur, Nagaland

Will the Minister of HOME AFFAIRS be pleased to state:

(a) whether curfew was imposed in Dimapur in Nagaland towards the close of the last month;

(b) if so, what were the reasons therefor; and

(c) whether any loss to life and property has been caused as a result of the incidents there; and if so, what is the extent of such loss?

THE MINISTER OF HOME AFFAIRS (SHRI CHARAN SINGH):

(a) Yes, Sir.

(b) and (c) On May 27 and 28, there were violent incidents in Dimapur resulting in injuries to several persons and damage to property. In order to control the situation, curfew had to be imposed in the affected areas from the 28th May, 1977. According to the reports received from the Government of Nagaland, a total number of 50 persons were treated for injuries, out of whom 6 were admitted in the hospital and the rest were discharged after medical aid. One of them later succumbed to his injuries.

In all 144 thatched houses/gumtis were burnt and 81 shops and 4 houses were damaged.

The Government of Nagaland has decided to appoint a Commission of Enquiry comprising a retired judge of the High Court to inquire into the incidents.
