(c) According to the orders issued in this behalf, certain criteria have to be fulfilled for eligibility of any grade for introduction of a Selection Grade. The Ministries/De-pariments are to examine the eligibility of each grade with reference to be prescribed criteria and also determine the pay scale for the Selection Grade, according to the prescribed norms, in consultation with the Ministry of Finance. The number of Group 'C' & Group 'D' cadres under the Government of India is fairly large, spread all over the country, in various offices. The eligibility of each cadre for selection grade will have to be examined with reference to the prescribed criteria, namely, the promotion prospects, source of recruitment etc. and this takes time.

DISAPPEARANCE OF FILES RELATING TO LOANS TO M/S. MARUTI LTD. FROM THE CENTRAL BANK OF INDIA

Central Bank of India has reported that one File containing correspondence and other papers concerning the account of Maruti Limited covering the period from December, 1971 to January 1974 is missing from the bank's Regional Office at New Delhi. The bank has informed that this loss was detected by the Regional Office in May 1974 but was reported to the bank's Central Office only in May, 1977. The bank has further reported that since almost all proposals and transactions were referred to or sanctioned and reported by its Regional Office, Delhi to its Central Office, Bombay, copies of most of the
