## STATEMENTS BY MINISTERS

By 'Samachar'

सूचना थ्रौर प्रसारण मंत्री (श्री लाल श्राडवाणी) : श्रीमन्, "समाचार" के गठन तथा इसके कार्यों ग्रौर इसके भविष्य के बारे में मैं एक वक्तव्य देना ग्रावश्यक समझता हूं; क्योंकि माननीय सदस्यों को यह पता है कि यह समाचार एजेंसी व्यापक ग्रालोचना का विषय रही है ।

मेरे पूर्वंवर्ती ने लोक सभा में 21 जनवरी, 1976 को दिए गए अनते वक्तव्य में एक एकल समाचार एजेंसी के गठन का औचित्य ठहराया था और यह कहा था कि सरकार ने यह वात सन्तोष के साथ नोट की है कि पी॰टी॰आई॰, यू॰ एन॰ आई॰, हिन्दुस्तान समाचार और समाचार भारती के प्रबंधकों ने एक एकल और सशक्त राष्ट्रीय समाचार एजेंसी के विज्ञार के समर्थन में अस्ताव पारित किए हैं। उन्होंने यह भी

कहा था कि इन एजेंसियों के प्रबन्धकों ने अपने को एक एकल एजेंसी में विलय करने का प्रस्ताव किया है और सरकार इस प्रक्रिया में विभिन्न तरीकों से सहायता करने के लिए वैसार रहेगी।

"समाचार" नाम से एक सोसायटी का 24 जनवरी, 1976 को पंजीकरण किया गया जिसकी प्रबंध समिति के 12 सदस्य थे ग्रौर 'हिन्द' के सम्पादक श्री जी० कस्तुरी इसके अध्यक्ष थे। पहले की चारों समाचार एजेसियों ने एक फरवरी, 1976 से "समाचार" के नाम से काम करने का निर्णय किया और 2 इप्रैल, 1976 से अपनी परिसम्पत्तियों और ायित्वों तथा भ्रपने कार्यों एवं व्यक्तियों को "समाचार" को हस्तांतरित करने के प्रस्ताव पास किए । इस पर "समाचार" ने पी० टी० ग्राई० ,यु० एन ०ई० ग्रीर हिन्द्स्तान समाचार के शेयर खरीद लिये, जबकि समाचार भारती के शेयर, जो मैसूर, गुजरात बिहार, राजस्थान और उत्तर प्रदेश की राज्य सरकारों के पास थे, "समाचार" के अध्यक्ष की प्रार्थना पर "समाचार" को दान स्वरूप दे दिए गए।

चारों समाचार एजेंसियों का पूर्ण एकी-करण करने के लिए "समाचार" ने (क) कर्मचारियों: (ख) दर ढांचा; तथा (ग) प्रशासनिक संहिता ग्रौर उपनियमों पर तीन समितियां नियक्त की । इन समितियों के भ्रष्टयक्ष कमशः श्री ग्रार०पी० विल्ली-मोरिया, जो अब एस० ए० आई० एल० ( SAIL ) के अध्यक्ष हैं, मैससं बेनट कोलमैन एंड टाइम्स आफ इंडिया के एसोसिएट जनरल मैनेजर डा० 'राम एस० तरनेजा, श्रौर 'जागरण' कानपुर के प्रबंध सम्पादक श्रीपी० सी० गप्त थे। व्यक्तियों के एकीकरण से सम्बन्धित समिति की कुछ सिफारिशें 'समाचार' द्वारा पहले ही स्वीकार की जा चकी है ग्रीर उसके कर्मचारियों के वेतन-मान युक्तियुक्त कर दिए गए हैं - ग्रौर वे
