an increase in the burden on the farmers have to be eliminated. So, I would request the honourable Minister to take this House into confidence about the approach that they are going to have. I know that he cannot announce the total policy now. But, Sir, he can indicate the approach of the Government, the thinking of the Government on the basis of the discussions held so far in regard the prices, about the commitment to procure at least five million tonnes of foodgrains this year and also in regard to the reduction of the cost and the issue prices.

SHRI PARKASH SINGH BADAL: Sir, some of these questions are again with regard to the food policy on which I cannot say anything now. One thing that the honourable member has brought to my notice is about the procurement price and what the farmers get. I will certainly issue instructions that such malpractices, if any, should be checked and the States have been asked to ensure that all grains of fair and average quality are bought direct from the farmers and not from the traders or any other persons.

श्री नत्थी सिंह (राजस्थान): चिलिए -श्राप नये रूप में तो श्राए।

श्री रेजिनारायण: भूपेश गुंदी जी ने मेरे संबध में बहुत गलत बातें कही हैं। मैं समझता था कि सदन में कुछ कहने के पूर्व यदि वह जानकारी प्राप्त कर लिये होते तो अच्छा था। सबसे अच्छे जज तो आप ही हैं क्योंकि उस अवसर पर आप मौजूद थे।

We asked whether the statement which is alleged to have been made there represents the policy of the Government Mr. Raj Narain should tell us whether the report is correct and, if so, whether he stands by the statement as a member of the Government and the Government stands by it. This is all that I want to know. Nothing beyond that. As far as his putting his hand on somebody's shoulder is concerned, it is a different thing.

MR. DEPUTY CHAIRMAN: I will request the hon. Members to see that we are not debating the foreign policy. The limited point at this stage is: In what way Shri Bhupesh Gupta has made a statement in the House which is not true to facts? Let us not go into a discussion about foreign policy or non-alignment or anything like that. It is not the time for it. The issue involved is a very limited one. In what way does the hon. Minister object or want to clarify any statement that Shri Bhupesh Gupta made in this House? He may kindly confine himself to just this point.

SHRI MOHAMMAD YUNUS SALE-EM: We are not here to listen to his party's manifesto.

SHRI RAJ NARAIN: Shri Bhupesh Gupta has said:

"But nowadays, it seems the moment Raj Narain comes, he runs away with better judgement.

Sir, Shri Raj Narain has been siting here. We all know him. He knows me. That is not the point. He is now a Minister of the Union Government and he was at a certain important international meeting of the Coordinating Bureau of the non-aligned countries. It is a very important occasion. There he made

such remarks and behaved in this manner."
