Low Tariff Hotels

1. SHRI HARSH DEO MALAVIYA:
Will the Minister of TOURISM AND
CIVIL AVIATION be pleased to state:

(a) the number of low tariff hotels along-
with their location that are proposed to be
constructed by the India Tourism Deve-
lopment Corporation for attracting more
tourists to the country during the current
year ; and

(b) by when the construction of such
hotels is likely to be completed ?

THE MINISTER OF TOURISM AND
CIVIL AVIATION (SHRI PUR-
SHOTTAM KAUSHIK) : (a) and
(b) As per the Annual Plan of the India
Tourism Development Corporation for
1977-78, there is provision for construction
of hotels at New Delhi, Chandigarh, Gau-
hati, Siliguri, Jaipur and Agra. The
facilities proposed to be provided in these
hotels would be of 2 or 3 star level and
these hotels would cater to the needs of low
and middle income groups of foreign
tourists.

The Government have, however, decided
to review the Fifth Plan and revise the
budget estimates for 1977-78 so that they
reflect appropriately Government priori-
ties.
