*32. SHRI SYED AHMAD HASH-MI: Will the Minister of WORKS AND HOUSING AND SUPPLY AND REHABILITATION be pleased to state:

- (a) whether it is a fact that the Delhi Development Authority has recently permitted the construction of an additional floor on the single storey houses built on 80 sq. yds. of land in Janakpuri New Delhi;
- (b) if so, whether Government propose to sanction additional House Building Advance to Government employees who own these houses to enable them to construct the additional floor; and
- (c) if not, what are the reasons therefor?

THE MINISTER OF WORKS AND HOUSING AND SUPPLY AND RE-HABILITATION (SHRI SIKANDAR BAKHT): (a) Yes, Sir.

- (c) House Building Advance is given only once in the entire service career. If an advance had been taken for the original house, ditional advance for its will not be admissible. However, if the employee had not taken any advance for the original house he can get an advance for the enlargement of the house.

The objective of House Buliding Advance is to give a limited assistance for the construction or purchase of a house, within limits. Where assistance had already been given upto the extent of the limit or the cost of the house whichever be lower the question of giving an additional advance for enlargement does not arise.
