

**Interest paid to the purchasers of
DDA flats on their deposits**

*44. SHRI SYED AHMAD HASHMI: Will the Minister of WORKS AND HOUSING AND SUPPLY AND REHABILITATION be pleased to state:

(a) whether Government are aware that the Delhi Development Authority invites deposits from intending purchasers of DDA flats at 7 per cent rate of interest as against 10½ per cent paid by the Nationalised Banks;

(b) if so, what are the reasons therefor;

(c) whether Government are also aware that the DDA does not pay the interest due on such deposits after the date of final draw;

(d) whether it is a fact that DDA also charges interest at 12½ per cent per annum for 15 days if the buyer is late in depositing the cost of the flat even by one day whereas the Authority does not pay any interest on the amount of deposit for the period for which possession of flat to the buyer is delayed by the DDA; and

(e) if so, what action Government propose to take in the matter?

THE MINISTER OF WORKS AND HOUSING AND SUPPLY AND REHABILITATION (SHRI SIKANDAR BAKHT): (a) Yes, Sir.

(b) The rate of interest varies with the period of deposits in the Nationalised Banks while in the Delhi Development Authority, the rate of interest is uniform at 7 per cent per annum with the additional advantage of getting a house allotted.

(c) Yes, Sir, interest is not allowed beyond the date of specific draw, as Delhi Development Authority thereafter arranges for transferring to him possession of the flat and the amount of deposit is credited towards the cost of the flat.

(d) Delhi Development Authority charges interest at 12 per cent per annum on delayed cash down payments by allottees. For calculation of

interest, periods less than 15 days are treated as half a month and more than 15 days as one month. Delhi Development Authority has reported that where they have not been able to give possession of the flat immediately after the date of specific draw, interest was allowed both on the amount deposited by the allottee towards cost of the flat and on the amount of registration deposit.

(e) No action is called for.

(a) whether it is a fact that the Kerala Government have requested the Central Government for the constitution of a Coconut Board;

(b) if so, whether any decision has been taken in the matter; and

(c) if the reply to part (b) above be in the negative, what are the reasons thereof?

THE MINISTER OF AGRICULTURE AND IRRIGATION (SHRI PARKASH SINGH BADAL): (a) Yes, Sir.

(b) and (c) A decision in the matter has not yet been taken. The details are being worked out in consultation with the concerned interests.

(a) whether it is a fact that the reduction in the prices of chemical fertilisers has not afforded any substantial relief to the farmers; and

(b) if so, whether Government propose to further bring down the prices of chemical fertilisers to the level obtaining before the first increase was announced?]

कृषि और सिंचाई मंत्री (श्री प्रकाश सिंह बादल): (क) जी नहीं। 18 जुलाई, 1975 से 8 फरवरी, 1977 की अवधि के दौरान उर्वरकों के मूल्यों में पांच बार कमी की गई थी। मूल्यों में की गई इन सभी कमियों के समग्र प्रभाव से किसानों को कुछ राहत मिली है।

(ख) उर्वरकों के मूल्यों की समय-समय पर समीक्षा की जाती है और जब कभी आवश्यक होता है, इनके मूल्य कम कर दिए जाते हैं।

†[THE MINISTER OF AGRICULTURE AND IRRIGATION (SHRI PRAKASH SINGH BADAL): (a) No, Sir. During the period 18-7-1975 to 8-2-1977, five reductions in the prices of fertilisers were effected. The combined effect of all these reductions has afforded some relief to the farmers.

(b) The prices of fertilisers are reviewed from time to time and as and when any reduction is called for, it is done.]
