Construction of the Tube Railway in Calcutta

Will the Minister of RAILWAYS be pleased to state:

- (a) the progress so far made in the construction of the tube railway in Calcutta;
- (b) what are the reasons for the delay in the execution of the project; and
- (c) by when the work is expected to be completed?

THE MINISTER OF RAILWAYS (PROF. MADHU DANDAVATE):
(a) The overall upto date progress of work on the Dum Dum-Tollygan) tube railway in Calcutta is 11 percent.

(b) and (c) Constraint of resources is the main reason for slow progress. The work can be completed by 1986 subject to availability of resources.

Incomplete preparation of Voters' lists

- *60. SHRI HARSH DEO MALA-VIYA: Will the Minister of LAW, JUSTICE AND COMPANY AFFAIRS be pleased to state:
- (a) whether Government are aware that during the recent General Elections to the Lok Sabha the names of a large number of eligible voters were missing in the lists of voters prepared by the Election Commission; if so, what are the reasons therefor; and
 - (b) whether Government propose to direct a door-to-door check to ensure that the name of each eligible voter is included in the Voters' lists?

THE MINISTER OF LAW, JUSTICE AND COMPANY AFFAIRS (SHRI SHANTI BHUSHAN): (a)

The electoral rolls of all the constituencies in the country were revised during 1976 summarily by publishing the existing rolls as the draft rolls and inviting claims and objections. Eligible electors who did not lodge their claims could not be registered and so there were some omissions.

(b) The nature of the revision of the electoral rolls to be carried out during this year is under the consideration of the Election Commission.

- (a) the number of pending cases in various High Courts as on April 1, 1977; and

A statement giving the information as on 31st December 1976 in respect of all High Courts except Allahabad High Court is placed on the Table of the House. In respect of Allahabad High Court, the information is as on 30th June 1976. (See below).

(b) The present Government is considering the steps which should be taken t_0 expeditiously clear the arrears.
