### ANNOUNCEMENT RE. PROCEDURE OF VOTING OF THE CONSTITU-TION (FORTY-FOURTH AMEND-MENT) BILL, 1976

MR. CHAIRMAN: I have to inform the Members that the procedure at the time of voting on the Constitution (Forty-fourth Amendment) Bill, 1976, as passed by the Lok Sabha, if the House agrees, may be as follows:

The motion for consideration of the Bill will be discussed on the 4th, 5th and 8th November, 1976 and on the 9th November, 1976 after the reply of the Minister, it will be put to vote at 12.00 Noon.

Clause-by-clause consideration of the Bill will take place immediately thereafter and will continue on the 10th also. Amendments to the clauses may be moved, considered and disposed of when that particular clause is under consideration. However, all the clauses and amended clauses of the Bill will be put to vote together at 5.30 P.M. on the 10th November, 1976. In case a Member wants any particular clause to be put to vote separately, voting on that clause will take place accordingly.

On the 11th November, the House will meet at 10.00 A.M. when the motion for passing of the Bill will be moved and voting 0n that motion will take place at 1.00 P.M. on that day.

I hope the House agrees with this procedure.
