Export Promotion and import •substitution are the two main measures through which it is proposed to •wipe off the adverse balance of trade. Among the measures recently taken in the area of export promotion, men- tion may be made of abolition of export duty on jute manufactures, strengthening of the production base of txport oriented industries, identification of items and areas with export potential, simplification of procedures, payment of cash compensatory support. *nd drawback of customs and excise duties, waiving of customs duty in the case of advance licences, liberalisation of import policy, grant of credit for longer period at concessional terms, liberalisation of Export Control Regulations, assistance in transport, etc. Further measures will be taken as the ·circumstances warrant.
