period will depend on the budget provision voted by the Parliament, and the requirements received from various States, for each year.

(c) A sum of Rs. 47.23 lakhs comprising of Rs. 39.10 lakhs under Allocation share and Rs. 8.13 lakhs under Ordinary Reserve was requested by the State Government. Against this a sum of Rs. 43.70 lakhs comprising of Rs. 35.57 lakhs under Allocation share and Rs. 8.13 lakhs under Ordinary Reserve was sanctioned during 1975-76 keeping in view the available resources and the requirements of other States.
