

constituency will be enlarged to include all types of teachers, not secondary school teachers only but college teachers and primary school teachers also? Why is the primary teachers' community excluded from voting in the teachers' constituency?

SHRI H. R. GOKHALE: Sir, the representation was received by the Prime Minister and was sent on to my Ministry in 1968. That representation only spoke of giving voting rights. That is why the first answer which I gave was "No, Sir", because the question was whether any representation in the Council was sought. But I thought they really intended that, although they mentioned "voting right" and, therefore, I gave the other answer also. Now, under the Constitution as at present, representation is given to the graduates as well as to teachers at the secondary or post-secondary level. Now the whole question is whether at all levels it should be given or not. I cannot say anything more than what I have said because the Government have not decided on the matter.

SHRI V. B. RAJU: Is the hon. Minister aware that this particular privilege for the teachers or the facility to get seats in the Legislative Council has involved the teachers' community in power politics and the educational institutions are thereby affected? If so, will the Minister think about it and examine whether this provision has to be deleted?

MR. CHAIRMAN: A good suggestion.

SHRI H. R. GOKHALE; I am aware of it and, in fact, that is one aspect which is very much borne in mind while considering this matter.

श्री एच० आर० गोखले : यह सूचना है; इस पर सोचेंगे।

SHRI B. N. BANERJEE: Sir, this question says "why not give representation to the primary school teachers in the Legislative Council on the same lines as the graduates". But is it not a fact that the hon. Minister has received representations or suggestions from other quarters that even the representation to the graduate teachers in the Legislative Council should be done away with in view of the point made by Shri V. B. Raju in his question?

SHRI H. R. GOKHALE: Yes, Sir. Representations both for and against have been received.

#### **Re-structuring of the financial set up of the Railways**

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI MOHAMMAD SHAFI QURESHI): (a) No, Sir.

SHRI KHURSHED ALAM KHAN: Sir, apparently it seems that the financial structure of the Railways is as outmoded as some of the locomotives on the North-Eastern Railway or the furniture provided in the rest-rooms or waiting-rooms of the North-Eastern

Railway. So, may I know from the hon. Minister whether, in view of the financial results of the Railways and the capacity of the Railways to pay back the dividend and the interest, is it not necessary to have fresh look at the whole question and take a view which will be more realistic?

SHRI MOHAMMAD SHAFI QURESHI: Sir, the financial position of the Railways has been under examination by the successive Railway Convention Committees and various reliefs have been suggested by the Committee from time to time, and the administration has been accepting their recommendations. I do not agree with the hon. Member when he says that the financial system of the Railways is outmoded. In any case, we have formed an experts group consisting of the Additional Member (Finance), Railway Board a Joint Secretary of the Ministry of Finance and the Adviser of the Transport and Communications Division Planning Commission^ to go into whole gamut of the financial structure of the Railways.
