Extension of 131/132 Nizamud-ciin-Mangalore/Cochin Jayanti Janata Express to and from Trivandrum Central can only be considered when the speed is increased and additional maintenance facilities are developed at Trivandrum.

Swadeshi drive on Railways

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SAR-DAR BUTA SINGH): (a) and (b) In pursuance of the 20-point Economic Programme, a vigorous Swadeshi Drive was launched by the Ministry of Railways in August, 1975 to eliminate dependence on imports.

With a view to providing first hand knowledge of items being imported by the Railways to as many industrialists and entrepreneurs as possible, a mobile exhibition was organised and taken to important industrial centres in India.

The break through in Swadeshi drive on the Railways has been achieved as a result of harnessing the technological skill available in the country by the coordinated efforts of the Production Units as well as the Zonal Railways under the guidance o^f -the highest level of management of the Ministry of Railways. During the past one year it has been possible for the three production units and Zonal Railways to take off from the import list as many as 181 items evaluated at Rs. 5.17 crores per annum.

Late running of trains after Basar Station
