Development of airstrips

439. SHRI MULKA GOVINDA REDDY: Will the Minister of TOUR-ISM AND CIVIL AVIATION be pleased to state:

(a) whether Government hav_e decided to develop HubM, Davangere and Bellary airstrips; and

(b) whether work has started on these projects; if not by when the work is likely to be taken in hand?

THE MINISTER OF TOURISM AND CIVIL AVIATION (SHRI RAJ BAHADUR): (a) and (b) The project for construction of an aerodrome at Hubli had been sanctioned and some preliminary works like collection of materials, casting of RCC pipes were started. However, due to tight budge, tary position the various schemes of the Civil Aviation Department had to be reviewed keeping in view Indian Airlines's future plans. Construction of an aerodrome at Hubli had, therefore, been postponed. It is proposed to review the proposal again subject to availability of resources.

There is no proposal to construct an aerodrome either at Davangere or Bellary.

S.B.I. scheme to help needy students

The Scheme has been implemented not only in Tamil Nadu but also in other States.
