In pursuance of the programme for the extension of cooperative coverage to 60% of the entire of the handloom sector and to strengthen the Handloom Apex Cooperatives and State Handloom Development Corporations, the State Governments have been requested to draw up suitable scheme for implementation.

It is accepted that textile policy has to be on an integrated basis taking into account the need to co-ordinate and harmonise the organised sector with the decentralised area of handlooms and powerlooms. Integration "has also to be attempted on a multi-fibre basis so that the policy relating to clothing of the public will be a coordinated one covering not only cotton but also man-made fibres and wool.
