THE DEPUTY MINISTER IN THE **EDUCATION** OF AND MINISTRY AND IN SOCIAL WELFARE THE DEPARTMENT OF CULTURE (SHR1 ARVIND NETAM): Sports teams for participation in Olympic Games are sponsored by the Indian Olympic Association, an autonomous organisation. According to the information received from it, the Indian Olympic Association had decided the Montreal Olympic to sponsor for Games, as a rule, only those teams/sportsmen who according to their performance would have obtained the sixth position at the Munich Olympic Games, 1972. Having regard however, to the fact that some of the sportsmen were young, with the potential to improve further and their performance was reasonably near to the sixth position standard mentioned above, the Association, in consultation with the All India Council of Sports, included them in the Olympic Contingent.

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE AND IRRIGATION (SHRI SHAH NAWAZ KHAN): (a) The problem of soil erosion on account of wind and water exists in

(b) The problem of soil degradation is being tackled in the country through the programme of soil and water conservation. It means prevention of all forms of soil degradation by using the soil according to its capability and treating it according to its needs with measures like contour bunding, terracing, gully control, water harvesting saline-alkaline land reclamation, afforestation and pasture development. The programme of soil and water conservation was initiated right from the beginning of First Five Year Plan period. By the end of Fourth Plan, an area of 18.85 million Ha, of agricultural and non-agricultural land are reported to have been treated with a total expenditure of Rs. 348 63 crores.

During the Fifth Plan period, an area of about 5 million hectares is likely to be covered a total outlay of with Rs. 262.93 crores.
