aims at economic rehabilitation of poor and destitute women. During 1974-75, the number of courses sanctioned was 135 in 1975-76. This was increased to 251 courses and in the current financial year 267 courses have been sanctioned upto 19th August, 1976. This shows the growing popularity of the programme.

## Harassment to traders on account of minor defects in their goods

781. SHRI SHYAM LAL YADAV: Will the Minister of HEALTH AND FAMILY PLANNING be pleased to state:

- (a) whether Government are aware that traders were subjected to harassment during the last year on account of minor defects, not injurious to human health, in their merchandise such as presence of wheat starch in the chilly powder, which could be detected only through microscope. if so, what are the details thereof; and
- (b) what action Government have taken to prevent the traders from being harassed on flimsy technical grounds?

THE DEPUTY MINISTER IN THE MINISTRY OF HEALTH AND FAMILY PLANNING (SHRI A. K. M. ISHAQUE): (a) The distinction between adulteration likely to be injurious to health or otherwise has been made in the Prevention of Food Adulteration (Amendment) 1976, but only for purposes of penalties. The amended legislation also exempts adulteration of certain types in primary foods, which may be solely due to natural causes beyond the control of human agency. There were certain complaints from traders ance is likely to be given to them?

during the last year, before the enforcement of the Prevention of Food Adulteration (Amendment) Act. 1976 on 1-4-76. that they were facing prosecution for cases of adulteration, which would have been exempted under the amended legislation.

(b) The Prevention of Food Adulteration (Amendment) Act, 1976 provides safeguards against harassment of traders by the enforcement staff and provides for lesser penalties for adulteration not injurious to health. Moreover, the standards fixed under the Prevention of Food Adulteration Rules are minimum standards and if the traders have any genuine difficulties in attaining the prescribed standards, they are free to approach the Central Committee for Food Standards with scientific data, for revision of the standards. The Committee includes representatives of the trade and there is every possibility of genuine difficulties being appreciated by them.
