Controversy between U.P. Government and the Archaeological Survey of India regarding entry fees for Taj and other monuments in Agra.

- 742. SHRI SAT PAUL MITTAL: Will the Minister of EDUCATION, SOCIAL WELFARE AND CULTURE be pleased to state:
- (a) whether it is a fact that there is a controversy between the Archaeological Survey of India and the U.P. ment over the recent increase in the entry fees at the Tai and other historical monuments of national importance at Agra; and
- (b) if so, what are the details in this regard?

THE MINISTER OF EDUCATION. SOCIAL WELFARE AND CULTURE (PROF. S. NURUL HASAN) (a) and (b) The Archaeological Survey of India has not increased the entrance fee at Taj Mahal, Agra Fort, Akbar's tomb and Itimadu'd-Daula's tomb. The U.P. Government is collecting a levy the precise particulars of which are being collected.

7.14.124 Death of white tiger Virat

- 743. SHRI SHRIKANT VERMA: Will the Minister of AGRICULTURE AND IRRIGATION be pleased to state:
- (a) whether Government have instituted an enquiry into the causes of death of the last male white tiger, VIRAT; and
 - (b) if so, what are the details thereof?

THE DEPUTY MINISTER IN THE MINISTRY OF AGRICULTURE AND IRRIGATION (SHR1 **PRABHUDAS** PATEL): (a) and (b) The Tiger 'Virat' was the private property of the Ex-Maharaja of Rewa. However, on a request from the Comptroller of Households of the Ex-Maharaja, when the tiger was seriously ill, the Director, Delhi Zoo, alongwith the Veterinary Adviser of the Zoo, rushed to Govindgarh for assistance. On examination,

the doctor considered it to be a case of enteritis and immediate acatment was accordingly given. The tiger was again examined on the following day and necessary medicines administered second time. Thereafter, the treatment was left to local doctors for continuing the injections and medicines as prescribed. Although a definite improvement was noticed in its condition. it relapsed after a few days and expired.

Opening of creative writing workshops in Universities

THE MINISTER OF EDUCATION. WELFARE AND CULTURE SOCIAL (PROF. S. NURUL HASAN): (a) and (b) According to information furinshed by the University Grants Commission, there is no proposal under its consideration to organise creative writing workshops in various Universities. Commission has, however, appointed a Committee to work out a scheme for instituting travelling fellowships/special Visiting Professorship for writers in the Universities.
