- (c) Pass-holders are allowed to travel in all the private mini buses engaged under the scheme indicated in (b) above. But this facility is not available on private mini buses engaged by D.T.C. prior to the introduction of the said scheme as it is not covered by the agreement entered into by D.T.C. with the bus-owners.
- (d) The areas where mini buses are operating are, also covered by other DTC services on which pass-holders are allowed to travel. Students do not, therefore, face difficulty due to non-validity of their passes on some of the private mini buses.

Difficulties to telephone subscribers in Gole Market area

- (b) whether it is a fact that telephones for registering complaints in the area also remain out of order;

- (d) if so, what remedial measures are being taken in this regard?

The telephone service to some subscribers in the area was, however, affected due to (i) cable fault during July/August, 1976, (ii) area re-arrangement and (iii) damage to the DPs in the veranda of Bhagat Singh Market when the municipal authorities dismantled encroachments.

- (b) No, Sir. 198 service for registering complaints from subscribers in this is work ing round-the-clock.
- (c) No, Sir. 198 service is regularly regis tering complaints from subscribers from this area
- (d) The working of the fault repair ser vice is kept constantly under watch and corrective action is taken promptly when ever any abnormality is noted.
