National Highway in Assam

- 387. SHRI SYED ABDUL MALIK: Will the Minister of SHIPPING AND TRANSPORT be pleased to state:
- (a) whether Government are aware of the deteriorating condition of the National Highway in Assam, particularly from Gauhati to Dibrugarh;
- (b) if so, what are the reasons for the delay in completing the construction of bridges and culverts on the National Highway; and
- (c) by when these are likely to be completed?

THE MINISTER OF SHIPPING AND TRANSPORT (DR. G. S. DHILLON):
(a) to (c) A statement giving the position is laid on the table of the Sabha.

Statement

- (a) The condition of National Highway 37 from Gauhati to Dibrugarh was not considered upto the mark and a critical as sessment was made by the Senior Technical Officers of the Ministry in 1975. Based on their report the following steps have been taken/are being taken to improve the road:—
 - (i) Five estimates tor special repairs costing Rs. 26.28 lakhs have been sanctioned in February/March 1976;
 - (ii) One estimate costing Rs. 46 lakhs for improvement of deformed stretches has been sanctioned in July 1976;
 - (iii) Another estimate costing Rs. 53 lakhs for improvement of deformed stretches is expected to be sanctioned shortly;
 - (iv) Estimates for worKs costing about Rs. 200 lakhs are awaited from the State Public Works Department.
 - (v) In addition to the above measures, funds are also allotted to the State Government from time to time for normal maintenance and repairs of the National Highways.
- (b) and (c) Out of the 24 bridge works sanctioned during the Fourth Five Year Plan period for the stretch of road from Gauhati to Dibrugarh, 21 bridges have al ready been completed. Out of the remain ing three minor bridges, two are in progress and are likely to" Be completed shortly. The work on the third bridge is expected to be taken up in near future.

Six estimates involving construction of 213 culverts at a cost of Rs. 31.88 lakhs were sanctioned during the Fourth Five

Year Plan period. Out of these 56 culverts have already been completed. The progress of remaining culverts was retarded firstly due to shortage of construction material like steel, cement etc. and secondly due to financial stringency. Only the inescapable works were taken up. Although the position of availability of construction material has improved, the estimates for the sanctioned works would need revision due to cost escalation before substantial progress can be made. The State Public Works Department are seized of the problem and are processing the revised estimates. The remaining culverts are likely to be completed by 1978-79.
