- (a) Export duty on Jute Tarpaulin and , Canvas at the rate of Rs. 200 per tonne and on certain varieties of twist and rope at the rate of Rs. 150 per tonne has, been abolished on 22nd April, 1976.
 - (b) There have been complaints from time to time from Labour Unions regarding increase in the work load and some retrenchments/lav-off. There has not been any report regarding mass scale lay-off or retrenchment other than in the closed units. The managements however, claim that labour trouble has arisen because of their attempts at cost reduction as a measure of economy. There have also been cases of lock-out and closure in respect of a number of mills due mainly to financial and labour trouble.

- (b) According to Central Government scheme of classification of towns for the purpose of grant of city compensatory allowance based on the recommendations of the Third Pay Commission and enforced from 1-11-1973, classification is determined with reference to the population of the Urban Agglomeration as shown in the 1971 Census Report. As Kamptee is a constituent unit of the Nagpur Urban Agglomeration, the Central Government employees wroking there have become entitled to city compensatory allowance with effect from 1-11-1973. The classification for the purpose of grant of house rent allowance is, however, determined with reference to the population of the concerned Municipality/ Corporation as shown in the 1971 Census Report. The population of Kamptee Municipality according to the 1971 Census being 53,412, it has been classified as 'C' Class town and Central Government emp-However, information to house tent allowance at 'C' Class rates only and not at Nagpur rates.
