the Hospitals under the control of the Delhi Administration; and

(b) if so what are the reasons for setting up the Board ?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY PLANNING (CHAUDHARY RAM SEWAK): (a) and (b) A Hospital Review Committee set up by Government to review the working of the CenIral ^ Government Hospitals in Delhi with a view to improvitijr the facilities for medical, surgical and specialist care had discussed the need for coordination among different hospitals in detail and felt that the absence of an overall planning and coordinating body had led to haphazard growth of hospital services in Delhi area. As recommended by this Committee, a Delhi Hospitals Board has been constituted under the general supervision of the Union Ministry of Health and Family^ Planning.

SHINDE): The Government of India's sanction to the Centrally Sponsored Scheme for the establishment of a 8 Hectare Cocoa Seed Garden at an outlay of Rs. 3,13,000 for the remaining period of the Fifth Plan has since been accorded on the 30th April, 1976.

THE DEPUTY MINISTER IN THE MINISTRY OF EDUCATION AND SOCIAL WELFARE AND IN THE DEPARTMENT OF CULTURE (SHRI D. P. YADAV) : (a) to (d) The scheme of establishment of Nehru Yuvak Kendras was started in 1972-73 and 185 Kendras have been sanctioned so far. Each Kendra is under the charge of a Youth Coordinator who is expected to organise a network of youth clubs and to coordinate the activities of Government, as well as those of voluntary agencies engaged in nation-building activities. Selection of Youth Coordinators is made by a Central Selection Committee from amongst candidates recommended by the State Governments. So far 87 posts of Youth. Coordinators have been filled up and the remaining are vacant.

Information regarding the total expenditure incurred on the Youth Coordinators till the end of March 1976 is being collected and will be placed on the Table of the Sabha in due course.

Closing down of Sugar Mills in U.P.

(a) whether it is a fact that a number of sugar, mills in Uttar Pradesh have oeen closed down due to shortage of sugarcane;

(b) if so, what are the details thereof and the reasons for the shortage of sugarcane;

(c) what steps have been taken by the Central Government to remedy the situation; and

(d) to what extent has it affected the production of sugar and the employment of workers in the Mills ?

THE MINISTR OF STATE IN THE MINISTRY OF AGRICULTURE AND IRRIGATION (SHRI SHAH NAWAZ KHAN) : (a) to (o) A statement is laid on the Table of Sabha.

fa) and (b) Most of the 77 sugar mills in Uttar Pradesh have stopped crushing for the season earlier than expected mainly because of shortage of cane caused by reduction in cane area, fall in average yield of sugarcane per hectare attributable to prolonged monsoon; waterlogging and lack of adequate winter rains, and large scale diversion of cane to gur and khandsari units. (c) Shortage of cane in U. P. this year has been, in the main, due to natural climatic reasons over which the Government have no control. To check diversion of cane from sugar factories to gur and khandsari units, guidelines were last issued in October, 1975 to State Governments to reserve areas for supply of sugarcane to the sugar factories, taking into account the requirements uild crushing capacity of the sugar factories and not .to issue ne.v licences for setting *up* of khandsari units within the zone of a sugar factory.

(d) The sugar production in U. P. during the current 1975-76 season is expected to be about 2.65 lakh tonnes less than the production of 1974-75 season. The ptccise effect of early closure of sugar factories on employment of workers is not known.

Rise in prices of pulses

SHINDE) : (a) and (b) There has been some seasonal rise m the prices of moong and urad recently but this has been more than off-set by the fall in the prices of other pulses. The price index for twises as a group has shown a continuous fall in recent weeks. This is attributed mainly :0 expectation of a significant increase in production during 1975-76 over the previous year's level of 10.4 million tonnes.
