and medium irrigation schemes by the end of the Fifth Five Year Plan period; and

(b) if so, what are the details in this regard?

THE DEPUTY MINISTER IN THE MINISTRY OF AGRICULTURE AND IRRIGATION (SHRI K. N. SINGH): (a) and (b) The 20-Point Economic Programme announced by the Prime Minister in July, 1975 envisages creation of additional irrigation facilities for 5 million hectares of land during the last 4 years of the Fifth Five Year Plan. This target is proposed to be achieved largely by the execution of ongoing major and medium irrigation schemes as also by taking up new schemes, requiring an outlay of about Rs. 2800 crores.

## National Board for Medical Education

- 91. SHRI DEORAO PATIL: Will the Minister of HEALTH AND FAMILY PLANNING be pleased to state:
- (a) whether there is any proposal under Government's consideration to set up a National Board for medical education which will enable doctors to obtain higher medical education; and
- (b) if so, what are the details in this regard?

THE DEPUTY MINISTER IN THE MINISTRY OF HEALTH AND FAMILY PLANNING (SHRI A. K. M. ISHAQUE): (a) and (b) The Government of India, Ministry of Health and Family Planning appointed a Warking Group in February, 1975 under Dr. J. B. Shrivastav. Director General of Health Services, to examine the need for uniformity in the standard of examination for the award of postgraduate degrees and diplomas and, if necessary, to suggest ways and means of achieving it either through one or more national examining bodies. The Group recommended that there should be a National Board of Examinations as an independent statutory body for the award of post-graduate qualifications and affording opportunities to Indian doctors to obtain these higher national qualifications in India. In pursuance of the recommendations of the Working Group, the Government of India have agreed, in principle, to the setting up of a National Board of Examinations.

For the present, the task of conducting these examinations has been entrusted to the Indian Academy of Medical Sciences.
