in Delhi will naturally depend on many factors, lite migration into Delhi from surrounding areas, natural growth of population in Delhi and dispersal of population from Delhi to outlying areas. With a view to controlling to growth of population in Delhi Government have already started implementing the National Capital Region Plan which has a time perspective upto 1981, for the present, coinciding with the Delhi Master Plan lime perspective. The exercise in regard to the future pattern of growth and development of the National Capital Region as well as that of urban Delhi tor the period beyond 1981 is yet to be undertaken. In the circumstances, it is difficult to give any precise estimate of the likely population of Delhi by the turn of the century as it would depend on many factors already referred to above.

(b) The plans for meeting the increasing needs would have to be fitted into such a long-term perspective plan when it is prepared.
