a high-yielding strain and technical know-how for the manufacture of streptomycin was J&upplied to them free of cost. The Company, however incurred an expenditure of Ks. 93,000/ as 'out of pocket expenses' on technical experts of M(s. Glaxo who visited their Plant at Pimri.

Introduction of Automatic WarningSystem and other electronic devices n

- 405. SHRI SHRIKANT VERMA: Will the Minister of RAILWAYS be pleased to state:
- (a) whether Government propose to introduce Automatic Warning System and other electronic devices in the Indian Railways to improve operational safety and efficiency;
- (tb) whether such devices have already been introduced in the Eastern Railway; and
- (c) what will be the estimated cost of introducing these devices in all the Zones of the Indian Railways?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SARDAR BUTA SINGH): (a) Yes. On selective basis in a phased manner.

- (b) Yes. Automatic Warning System has been introduced on the Gaya-Mughalsaria Section and is in progress on the Howrah-Dankuni-Burdwan Section of the Eastern Railway.
- (,c) The estimated cost cannot be given at this stage as the work is proposed to be introduced in a phased manner.
