## Rise in the prices of and adulteration in lubricating oils

tt\*296. SHRI GUNANAND THAKUR: SHRI KHURSHED ALAM KHAN: SHRI IBRAHIM KALANIYA:

Will the Minister of PETROLEUM be pleased to state:

- (a) whether it is a fact that the prices of lubricating oil have gone up considerably; if so, what steps Government have taken to bring down the prices;
- (b) whether it is also a fact that lubricating oils sold in the market are generally adulterated;
- (c) if so, what action Government have taken or propose to take to curb this practice;
- (d) whether Government have issued any guidelines for the benefit of the consumers by which adulteration in lubricating oil can be detected?

THE MINISTER OF PETROLEUM (SHRI KESHAV DEO MALAVIYA): (a) to (d) A statement is laid on the table of the House.

#### Statement

- (a) There has been an increase in price of lubricating oils from March, 1974. The pricing of petroleum products including lubricating oils is under the consideration of the Oil Prices Committee set up by the Government which is expected to submit its final report shortly.
- (b) Lubricating oils are mostly sold through recognised distributors/ dealers of the major oil companies,

and Government have not come across serious complaints about the quality of lubricating oils sold from these retail outlets. Government are, however, aware of some allegations regarding sale of spurious/off-specification lubricating oils by private processors/marketers/petty jobbers and unauthorised dealers.

- Government have initiated follow up action on the measures re commended by an expert panel set up by the Government to. look into problem of adulteration/mis-use lubricants and suggest comprehensive measures to prevent adulteration. Separately Government have issued a scheme of discipline in regard to dis tribution of lubricants which is re quired to be implemented by all the major oil companies. Oil Companies have been directed to mount deter mined an energetic efforts by way of repetitive surprise checks on their re outlets/agents with a view eradicate such practices as mis-use/ adulteration. The oil companies have also been asked to increasingly take up direct sales to consumers.
- (d) Quality of lubricating oil can not be detected by visual inspection. Detailed laboratory tests are required to b<sub>e</sub> conducted to establish whether the quality of lubricating oils sold conforms to prescribed standards. Consumers' Cooperation by way of their purchasing lubricating oils from only the recognised outlets of major oil companies would, however, assist in minimising the sale of sub-standard lubricating oils.
