(c) what price has been fixed for the purchase of each variety of jute during the current season!

THE MINISTER OF COMMERCE (PROF. D.P. CHATTOPADHYAYA): (a) and (b) Maintenance of Statutory minimum price for raw jute is the responsibility of the Jute Corporation of India. Jute Corporation of India has been provided with a credit limit of Rs. 24,00 crores for the present.

(c) Statutory minimum price fixed for Assam Bottom and comparable varieties in the up-country markets for 1975-76 jute season is Rs. 135 per quintal.

While recruitment to officers cadre is generally made on all-India basis, recruitment to Clerical and Subordinate Stall is *nade on regional basis. Statewise information is not maintained by all bank! as in a large number of them recruitmen! is made through their regional olfices covering areas in more than one State/ Union Territory.

THE MINISTER OF REVENUE AND BANKING (SHR1 **PRANAB** MUKHERJEE): (a) and (b) Relevant data in respect of Cooch-Behar and Jalpaiguri districts of West Bengal have been called The for. suitability of Cooch Behar/Jalpniguri for the location of a Regional Rural Bank will be considered along with other probable locations of such banks, by the Steering Committee on Regional Rural Banks having regard to the criteria that-

- (i) the area is comparatively backward and its coverage by the commercial and cooperative banks is relatively poor; and
- (ii) the area should have good potential for agricultural growth once the flow of credit is assured.
