State cadre in Sikkim for All India Services

Will the PRIME MINISTER be pleased to state:

- (a) whether it is a fact that the State cadre in Sikkim for the All India Services has not yet been constituted; and
- (b) if so, what are the reasons therefor and by when it is likely to be constituted?

THE MINISTER OF STATE IN THE DEPARTMENT OF PERSONNEL AND ADMINISTRATIVE REFORMS (SHRI OM MEHTA): (a) and (b) The All India Services Cadres for Sikkim are being constituted in consultation with the Government of Sikkim. The notifications constituting the Cadres in Sikkim for All India Services are likely to issue shortly.

Posts lying vacant in the Computor Centre, Ministry of Planning

607. SHRI N. H. KUMBHARE: Will the Minister of PLANNING be pleased to state:

- (a) whether it is a fact that a number of posts in various cadres of class I are lying vacant for a long time in the Computor Centre, Department of Statistics in the Ministry of Planning;
- (b) whether it is also a fact that employees taken on deputation from other offices have been appointed to some of these vacant class I posts in preference to class II employees of the Centre who are eligible as per the recruitment rules of the Centre for promotion to these class I posts; and

(c) if so, what are the reasons for not promoting eligible officers from Computer Centre itself?

THE MINISTER OF STATE IN THE MINISTRY OF PLANNING (SHRI SANKAR GHOSE): (a) Out of a total sanctioned strength of 35 Group 'A' (former Class I) posts, 7 are vacant for a period of 2 years or more. These have not been filled so far on grounds of economy, pending review of the actual staff requirements of the Computor Centre.

(b) and (c) There was six short-term vacancies in the Grade of Assistant Director. As these were short-term vacancies, it was decided after consultation with U.P.S.C. that 50 per cent may be filled by promotion and 50 per cent by deputation from other offices. As the case of the third promotee is still under consideration, so far five posts have been filled two by promotion and three by deputation.
