

Coal mines nationalised by the Coal Mines (Nationalisation) Amendment Ordinance

&55. SHRI JAMNALAL BERWA: Will the Minister of ENERGY be pleased to state:

(a) the number of coal mines which have been nationalised as a result of the promulgation of the Coal Mines (Nationalisation) Amendment Ordinance of 29th April, 1975;

(b) the number of coal miners and other employees who have been affected by the Ordinance; and

(c) the manner in which Government purpose to rehabilitate or compensate the persons affected by the Ordinance?

THE DEPUTY MINISTER IN THE MINISTRY OF ENERGY (PROF. SIDDHESWAR PRASAD): (a) to (c) No coal mine has been nationalised as a result of the promulgation of the Coal Mines (Nationalisation) Amendment Ordinance of 29th April, 1976.

Hence the question of payment of compensation or rehabilitation of persons affected does not arise.
