The tailoring charges for cotton trousers, cotton halfsleeved shirts, and cotton blouses and kurtas only are regularly collected in the first week of every month by Bureau of Economic & Statistics, Delhi Administration for constructing Consumers' price Index Number for Industrial Workers. The rates are collected from five markets, namely Subzimandi, Bara Hindurao, Shahdara, Boghal and Moti Nagar. The statement below indicates the average tailoring charges from January 1973 onwards:
