श्री शाहनवाज खां : मैं अर्ज कर चुका हूँ कि उत्तर प्रदेश में जितने भी गोदाम हैं उनमें गल्ला भरा पड़ा हुआ है । उनके पास अपने स्टॉक में और सेण्ट्रल स्टॉक में करीब 12 लाख टन अनाज पड़ा हुआ है । आज हालत यह है कि वहाँ पर जो डिस्ट्रिब्यूशन सिस्टम है वहाँ से लोग अनाज नहीं खरीद रहे हैं क्योंकि ओपन मार्केट में अनाज की कीमत उसके मुकाबले में और भी कम हो गई है । मैं उत्तर प्रदेश की सरकार को मुबारकबाद देता हूँ कि उन्होंने अनाज के मामले में सेल्फ सफिशिएन्सी हासिल कर ली है ।

#### Recommendations of the convention of Co-operative Group Housing Societies

\*67. SHRI LAKSHMANA MAHA-PATRO: Will the Minister of WORKS AND HOUSING be pleased to state:

(a) whether Government have received the recommendations made by the convention of the co-operative group housing societies of Delhi which was held on the 8th February, 1976;

(b) if so, what are the main recommendations made by the convention; and

(c) what action Government propose to take thereon?

THE MINISTER OF WORKS AND HOUSING (SHRI K. RAGHURAM-AIAH): (a) Yes, Sir.

(b) That the group housing societies should be given land at cheaper rates, near the place of duty of its members; that normal ground rent should be charged, and the societies should be allowed to cover more area, and loan should be given to the societies for constructing houses at cheaper rates.

(c) No decision has yet been taken.

SHRI LAKSHMANA MAHAPATRO: Sir, on this group housing scheme, delegates from 160 organisations met on the 8th of February, and I have got with me a copy of the papers that they sent to the Central Government. They have said that they are very anxious to have the 20-point programme implemented but the scheme as it is has failed to inspire these co-operatives to make full contribution to solve the housing problem and, therefore, they have demanded, in addition to what the Minister just now stated, a drastic revision of the scheme and further that it may be converted into a scheme for co-operative plot housing societies or mutual benefit building societies. What has the Government to say on these two recommendations?

SHRI H. K. L. BHAGAT: Sir, as I have submitted already, I had mentioned the major recommendations of the convention. Now those recommendations have been received. The Government will examine them.

MR. CHAIRMAN: Any supplementary?

SHRI LAKSHMANA MAHAPATRO: As the Government is taking the plea that it is still under examination, I think, no second question would arise, Sir.

SHRI KHURSHED ALAM KHAN: May I know from the hon. Minister, Sir, whether any committee has been set up in Delhi, and as to how many times this committee has met since it

was set up, and what the terms of reference of this committee are? Sir, this problem has really assumed big dimensions and it is increasing day by day.

**SHRI H. K. L. BHAGAT:** Sir, the hon. Member has talked of a committee but he has not said what committee and regarding what. He talked of a committee. I want to know . . .

**SHRI KHURSHED ALAM KHAN:** The group housing committee to look into the matters of group housing.

**SHRI H. K. L. BHAGAT:** Sir, recently the Government appointed a committee to enquire into the working of co-operative house building societies in Delhi under the chairmanship of Shri B. N. Lokur. The hon. Member happens to be a member of this committee. There terms of reference of this committee, I have with me. If he wants to know how many meetings have been held, I think, he knows it better than me.

**SHRI H. K. L. BHAGAT:** Sir, I cannot give any time-limit but the matter is being examined, as I have submitted earlier.
