Victimisation of Workers by Hindustan Lever Ltd.

*143. SHRI JAGJ1T SINGH ANAND: SHRI YOGENDRA SHARMA:

Will the Minister of LABOUR be pleased to state:

- (a) whether it is a fact that certain top office bearers of the Central Committee of the All India Union of Workers have been recently victimised by the management of the Hindustan Lever Limited;
- (o) whether it is a fact that the terms and conditions of service of the field force members have been changed arbitrarily by the Company to the disadvantage of the workers in violation of written commitments;
- (c) whether it is a fact that the manage ment of the Hindustan Lever Limited is taking advantage of the Emergency to dis continue the practice of consultation & dealing with the recognised unions of wor kers irrespective of the workers participation programme envisaged under the 20-Point Programme;
- (d) whether Government have received representations from the workers in this regard; and
- (e) if so, what action Government have taken in the matter?

THE MINISTER OF LABOUR (SHRI K. V. RAGHUNATHA REDDY): (a) to (e) There were representations recently to the Ministry of Labour regarding alleged victimisation of workers by the management in their Ghaziabad and Etah units. The matter essentially came in the State Sphere and was brought to the attention of the Government of Uttar Pradesh. Issues/ grievances, if any, which remained outstanding could be taken by the aggrieved employees to the State Industrial Relations Machinery.

Justice Moidu's report on working Journalists

- ♦144. SHRI RABI RAY: Will the Minister of LABOUR be pleased to state:
- (a) what are the recommendations of the report of Justice Moidu on the membership of National Union of Journalists and Indian Federation of Working Journalists; and
- (b) what is Government's decision thereon?

THE MINISTER OF LABOUR (SHRI K. V. RAGHUNATHA REDDY): (a) Justice Moidu was entrusted with the work of verifying the membership strength of working Journalists of the Indian Federation of Working Journalists and National Union of Journalists (India) and the verification has established that the total membership strength of the Indian Federation of Working Journalists in the entire country was 2950 and that of the National Union of Journalists was 1138 as on 31-12-1974.

(b) In view of the finding of Justice Moidu's report that a little more than 72 percent of the Working Journalists owe allegiance to the Indian Federation of Working Journalists, Government decided to give two seats to the representatives of the Indian Federation of Working Journalists.

Allotments for flood damage repairs to National Highways are made under two categories *viz.* 'Continuing' flood damage repairs and 'New works'. Funds for these works are released on the basis of admisibility determined through scrutiny of detailed estimates received from States, progress of expenditure and availability of resources.

For Gujarat, a sum of Rs. 41 -11 lakhs has been allotted in 1975-76 keeping in view the aforesaid factors for 'Continuing' works of repairs of damages due to floods occuring prior to 1975 after scrutinising the requirement of Rs. 69 -70 lakhs projected by the Government of Gujarat. As regards repairs to damages by 1975 floods, estimates amounting to Rs. 16 -20 lakhs for temporary restoration have been approved against which a sum of Rs. 15-00 lakhs has been allotted. Some estimates have been returned to the State Government for clarification and same are in the process of scrutiny.

Irimpanam-Kalamasserry road in Kerala

- •146. SHRIMATI LEELA DAMODARA MENON: Will the Minister of SHIPPING AND TRANSPORT be pleased to state:
- (a) whether it is a fact that the Kerala Government have requested the Central Government for taking up the work on the Irimpanam-Kalamasserry road and including it under the C.R.F. Special Reserve Fund to be implemented during the Fifth Five Year Plan period; and
- (b) if so, what action Government have taken thereon?

THE MINISTER OF SHIPPING AND TRANSPORT (DR. G. S. DHILLON): (a) and (b) Although the Kerala Government have not proposed the road for inclusion under the C.R.F. Special Reserve, they had proposed its inclusion under the programme of "Special Area Development Schemes and Central Ministries requirements" during the Fifth Plan. The State Government were informed in June 1974 that this programme was meant for road projects sponsored by the Ministries of the Govt, of India and that financial assistance against this programme could, therefore, be considered unless the road project was sponsored by a Ministry of the Government of India.
