M/s. Smith Stanistreet & Co. Limited have built up an inventory of drugs worth Rs. 70 lakhs. The production has, therefore, deliberately been curtailed so that the inventory level is reduced.

The Company expects to clear the excess inventory by the end of March '76 and to resume production at higher levels from April '76 onwards,

SETHI): (a) and (b) There is no price or distribution Control on Soaps and Synthetic Detergents except on Janata Toilet Soap where the manufacturers in the organised sector have agreed to sell the product at 90 paise plus local taxes for a cake of 100 gms. The prices of standard grade toilet soaps produced in the organised sector are comparable.

The prices of Synthetic detergents are determined to a large extent by the formulation (including the level of incorporation of the active matter and builders), consumer preference, marketing ability of the manufacturers etc. Since there is no uniformity in the formulations in the market, a fau comparison is not possible.
