(c) to (e) A new Centrally sponsored scheme called Valmiki Ambedkar Awas Yojna (VAMBAY) is being implemented since 2.12.2001 with a view to provide shelter or upgrade the existing shelter for the urban slum dwellers living below poverty line who do not possess adequate shelter. The scheme has the primary objective to facilitate the construction and upgradation of the dwelling units for slum dwellers and provide healthy and enabling urban environment through community toilets under Nirmal Bharat Abhiyan (a component of the scheme). Government of India gives 50% subsidy in this scheme and the balance 50% is borne by the concerned State Government.

THE MINISTER OF STATE OF THE MINISTRY OF URBAN EMPLOYMENTAND POVERTY ALLEVIATION (KUMARI SELJA): (a) and (b) As per the Planning Commission's Estimates in 1999-2000, the total number of persons living below the poverty line in urban areas is 6.70 crore. As per the employment and unemployment rounds of National Sample Survey Organisation (NSSO), the estimated number of unemployed in the country was 2.66 crore in 1999-2000.

(c) Tenth Five Year Plan envisages creation of 50 million employment opportunities. To create employment potential, the Tenth Plan has identified the labour intensive sector and sub-sectors for development: agriculture, including social forestry, animal husbandry, fishing, horticulture and related areas and small and medium industries, construction, tourism, information technology, financial sector, education and health.

For the urban areas, Government is implementing an employment oriented urban poverty alleviation programme namely Swarna Jayanti Shahari Rozgar Yojana (SJSRY) w.e.f. 1.12.1997. The scheme strives to provide gainful employment to the urban unemployed or underemployed through encouraging the setting up of self-employment ventures or provision of wage employment.

Under SJSRY, in urban areas, targets for setting up of 4 lakh micro enterprises and skill upgradation training to 5 lakh persons, living below the poverty line, have been fixed in the Tenth Plan.
