Transport system in Delhi

- (a) whether the transport in public and private sectors available in Delhi is not being utilised in a coordinated way;

- (c) what are Government's plans to ensure better coordination and maximum utilisation of the available capacity?

THE MINISTER OF SHIPPING AND TRANSPORT (DR. G. S. DHIL-ON): (a) to (c) A statement giving the information is laid on the Table of the Sabha.

Statement

Presumably, the reference is to coordination between the public and private sectors in the sphere of passenger road transport. The bulk of the passenger transport services in Delhi is provided by Delhi Transport Corporation. The route planning is done by the Corporation in such a manner that its services do not run parallel to those provided by the private bus owners.

In the context of the oil crisis, the Planning Commission has emphasised the need for shift from personalised to public transport. The outlays provided to the DTC, in 1974-75, 1975-76 and 1976-77 (Rs. 7.92, Rs. 3.30 and Rs. 6.50 crores likely for 1976-77 respectively) represent a significant step up over the outlays provided in the earlier years (Rs. 1.97 crores, 2.57 crores and Rs. 5.85 crores in 1971-72, 72-73 and 73-74).

As regards coordination between the Railways and D.T.C. at present, the needs of city transport in Delhi are catered to mainly by the D.T.C. However, the Railways operate suburban services in Delhi which are being gradually strengthened.

Transfer of Telephone Connections

*255. SHRIMATI LAKSHMI KU-MARI CHUNDA'WAT:

- (a) whether it is a fact that a telephone connection sanctioned under the special category of 'Public Man' is not allowed to be transferred in the name of other person and if so, the reasons therefor:
- (b) whether it is also a fact that a social worker has to face lot of difficulties in getting his telephone transferred from one place to another from where he proposes to continue his activities: and
- (c) whether Government propose to relax the conditions for categories mentioned in parts (a) and (b) above?

THE MINISTER OF COMMUNI-CATIONS (SHRI S. D. SHARMA): (a) to (c) Transfer of telephones from the name of one person to another is at present permitted only in respect of OYT telephones and General Category telephones after they have been functioning for a period of three years. Transfer is not permitted in respect of these categories of telephones if sanctioned out of turn. Special category telephones including Public-men category not allowed to be transferred since priority these are sanctioned on basis. Transfer is permitted in respect of all categories of telephones to the near relations after the death of the subscriber.
