Foreign Minister renewed the invitation of the Government of India to the Government of Bangladesh for holding talks, without any pre-conditions, on allocation of the Gangawater flows during the lean months. In a formal note presented to the Bangladesh High Commission on 12 March, Government of India have once again urged and invited the Government of Bangladesh to hold talks.

#### National Highways in Gujarat

THE DEPUTY MINISTER IN THE SHIPPING MINISTRY OF AND TRANSPORT (SHRI DALBIR SINGH); (a) and (b) The total length of National Highways in Gujarat is 1352 kms, including 270 Kms in respect of the Gujarat portion of N. G. No. 15 added to the National ways system on 7-3-72. No new addition has since been made to the National Highway system in any State in the Country including Gujarat.

#### Mobile Post Offices in Gujarat

THE MINISTER OF COMMUNI-CATIONS (SHRI S. D. SHARMA): (a) There are two mobile post offices working in Gujarat—one in Ahmedabad city and the other at village Nimlai in District Valsad.

(b) A Mobile EDBO in village Vasai in District Sabarkantha has been approved and will be opened shortly.

# Excess charges against telephone calls in Gujarat

405. PROF. RAMLAL PARIKH: Will the Minister of COMMUNICATIONS be pleased to state:

- (a) the number of complaints received by the Telephone Department in Gujarat regarding excessive charges of telephone bills; and
  - (b) the action taken in the matter?

THE MINISTER OF COMMUNICA-TIONS (SHRI S. D. SHARMA): (a) Total number of complaints as on 1-4-75 was 11,518. Out of these, 5052 complaints were of alleged excess bilting on local calls and the rest 6466 complaints were due to clerical error at various stages.

(b) The complaints were investigated and rebate of local calls granted in 328 complaint cases and the clerical errors were corrected in 4160 complaint cases. There 6643 cases where the contention of the complainants had been rejected as the allegations of the complainants garding excess billing could not be established. There were 387 complaint cases which remained pending 28-2-76 for finalisation in order to reduce the incidence of clerical errors supervision has been lightened staff at all stages has been cautioned. To reduce complaints of excessiv**e** local calls exchange equipments are also being regularly checked.
