श्री प्रकाश चन्द बी० सेठी : जहा तक उर्वरकों की खपत का प्रश्न है, इस वर्ष में फास्फेटिक फरिलाइजर की खपत में कमी जरूर रही है। इसकी खासवजह यह थी कि इसके भाव कुछ ज्यादा थे। परन्त उत्पादन में किसी प्रकार की कोई कमी करने या नये युनिट जो बन रहे हैं उनमें किसी प्रकार की कमी करने का कोई इरादा नहीं है। वल्कि भाशा यह की जाती है कि नये साल की बन्सिवत इस साल उत्पादन में वृद्धि होगी। पहले उर्वरकों का उत्पादन 1.5 मिलियन टन हम्रा था ग्रौर म्रव म्रगले वर्ष में 1.8 मिलियन टन उत्पादन होने की संभावना है। जैसा मैंने कहा, फास्फेटिक फर्टिलाइजर की खपत में कुछ कमी रही क्योंकि इसके भाव काफी ज्यादा थे। इसी वजह से माननीय सदस्य ने इस बात को देखा होगा कि फाइनेन्स मिनिस्टर महोदय ने वजट में इसके भावों में काफी कमी की है। युरिया फरिलाइजर में 100/- ह० की कमी की गई है ब्रौर इसी प्रकार से फास्फेटिक फर्टिलाइजर में 200/- ह० से 600/- ह० प्रति टन के हिसाब से कमी की गई।

## Bibinagar-Nadi Kudi railway line

Will the Minister of RAILWAYS be pleased to state:

- (a) what is the progress of struction work of the new Bibi-nagar Nadi Kudi railway line; and
- (b) by when the proposed line expected to be completed?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS: (SARDAR BUTA SINGH): (a) Final Location Survey for the construction Nadikude-Bibinagar new line has ben completed and construction work on Bibinagar-Nalgonda section has been taken up.

(b) The project is epected to be completed by April, 1980 subject to the timely availability of adequate funds.

SHRI R. NARASIMHA REDDY: Sir, this project is a very important project, and it came after an precedented agitation in Andhra. This was inaugurated by the Prime Minister on 7-4-74, and it was then said that by 1978 this project would be completed. Sir, in view of the importance of this project from political, economic and psychological points of view, will the hon. Minister say whether the amount that is now sanctioned, Rs. 30 lakhs, is enough, and in this way this project will be completed by 1980?

SHRI BUTA SINGH: Sir, there is no dispute on the point that this project is very important. It is also a fact that this project was inaugurated by the hon. Prime Minister in April, 1974. But, Sir, as you would kindly notice, with the allocation of funds that has been made and placed at our disposal, it may not be possible adhere to the announcement that has just new mentioned by been Member. Sir, in view of this difficulty, I am afraid it will not be possible to complete this project within the stipulated period.

Oral Answers

SHRI R. NARASIMHA REDDY: Sir, we are now told that it will not be possible to complete this project within the stipulated time. Then. was this stipulated announced for this prestigious project, which was given to the people of after an unprece-Andhra Pradesh dented agitation? May I requeset the hon. Minister to seriously consider this aspect and sanction at least Rs. 5 crores in the current year for project?

SHRI BUTA SINGH: Sir, in the background with which the hon. Member has put this question, we have already requested the Planning Commission separately for the additional allotment of funds for this We are awaiting project. reply. As and when funds are made available, we will definitely take it

SHRI KHURSHED ALAM KHAN: Sir, from the replies given by hon. Minister, it appears that there is no clear thinking on the subject. There also appears to be lack of thinking and planning. I would like to know whether any phased programme is made out in respect of such projects keeping in view the resources available, the urgency of the project and the requirements of the project.

SHRI BUTA SINGH: Sir, the hon. Member will agree with me that thinking and planning cannot lie separated from the availability of funds. We have taken up the phased programme also. In the first phase, the work that has been taken in hand is from Bibinagar to Nalgonda. work is going on according to the funds that have bee placed at disposal.

SHRI BUTA SINGH: It is a fact that the Andhra Pradesh Chief Minister has written indicating priority of this project. We have written separately also and the State Governments request has also been forwarded to the Planning Commission for allocation of funds.
