(a) to (c) With the assistance of Swedish International Development Authority, a feasibility study was carried out in 1975 by two international lady experts, to identify new trades/occupations for women. Based on their report, another ILO expert has finalised a Project Report which is now under the consideration of Government.

The Project envisages provision of training facilities in basic and advance skills in selected trades having significant employment potential like dress-making, work, garment knitting, hosiery, electronics and secretarial practices. Short-term specialised courses are also proposed organised for the upgrading and retraining in selected fields as considered necessary.
