THE MINISTER OF EXTERNAL AFFAIRS (SHRI Y. B. CHAVAN): (a) On the 28th February, 1976 the BBC televised a film which caused great resentment among the Asian community in Britain. Asian Immigrant Associations in Britain protested to the BBC about the! film and also sought a Court injunction to slop repeat screening of the film. They were not successful and consequently the, film was repeated on the 6th March.

(b) The Government has noted with concern and sympathy the feelings of the Asian community in Britain and is watch ing the situation carefully.
