

The National Pavilion covered an area of 426 sq. metres and the display area of Specialised Commodity Halls was 308 sq. metres. Sixty six Indian firms and organisations displayed their products in the National Pavilion and twenty firms participated in the Specialised Commodity Halls.

3. According to preliminary reports received from the Fair, orders worth about Rs. 28 million were booked in respect of nigerseed, sesame seeds, oil cakes, tea, crushed bones and valve-guides. The business under negotiation is reported to be over Rs. 30 million mainly for items like textiles, food and marine products, handtools, machine tools, sanitary fitting and electronic items. Orders of about Rs. one million are expected for new items like sports goods, coir products, leather shoe upper and electronic calculators.

#### **S.B.I. enquiry into loan scandal at Sonapat**

693. SHRI RABI RAY: Will the Minister of REVENUE AND BANKING be pleased to state:

(a) 'whether it is a fact that the State Bank of India had advanced huge amounts as loan to industrialists at Sonapat who disappeared after taking the loan;

(b) 'if so, whether the officials of the State Bank are enquiring into this loan scandal; and

(c) 'what is the result of the enquiry?

THE MINISTER OF STATE IN CHARGE OF DEPARTMENT OF REVENUE AND BANKING (SHRI PRANAB MUKHERJEE): (a) to (c) In accordance with the practices and usages customary amongst bankers and also in accordance with the provisions contained in the State Bank of India Act, 1955, information relating to affairs of constituents of banks cannot be divulged.

The State Bank of India has however reported that in the case of one of the borrowing units of its Sonapat branch, the persons managing the

unit are at present not traceable. The bank has further reported that while no enquiry is being held by it of any loan scandal, it is taking the usual steps to recover its advances to this unit.

#### **Trade talks with Tanzania**

694. SHRI D.N. DWIVEDI: Will the Minister of COMMERCE be pleased to state:

(a) the broad features of the trade talks held recently between India and Tanzania; and

(b) whether India has been approached to set up large-scale as well as small-scale industries in Tanzania?

THE DEPUTY MINISTER IN THE MINISTRY OF COMMERCE (SHRI V. P. SINGH): (a) and (b) Presumably the hon'ble Member is referring to the Indo-Tanzanian talks held in New Delhi in January, 1976 in connection with the first meeting of the Indo-Tanzanian Joint Commission. A statement showing the highlights of the talks is attached

#### *Statement*

The highlights of the understanding reached during the deliberations in the Indo-Tanzanian Joint Commission are as follows:

(1) The two countries have emphasised the importance of co-operation by developing countries as provided in the Resolutions adopted at the Lima-Conference of the Non-Aligned nations.

(2) The two countries will collaborate in the expansion of a Salt project in Tanzania, setting up of a water pumps manufacturing plant for agricultural use and establishment of prototype training cum-production centres

for development of small scale industries in the field of agro-industries, textiles, minerals based industries.

(3) A review, of Indo.Tanzania trade was made and the two sides reached an understanding or a common approach to the problem of marketing and processing of raw cashew-nuts and cooperation in setting up of the Tea Commodity Community and a Cardamom Community.

(4) Economic and technical cooperation in deputation and training of railway experts, pilots and ground engineers, construction engineers, agricultural scientists and experts in cement industry and small scale industries will be expanded. India will train commercial pilots and ground engineers as well as afford training facilities for Tanzanian personnel in in-plant and institutional training in small scale industries, railways in scientific institutions, Indian experts will be made available in the field of railways, construction engineering, and agricultural research.

#### **Amalgamation of rural financial institutions**
