THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI MD. ALI ASHRAF FATMI): (a) Yes, Sir.

- (b) During the year 2003-04, 4610 Government colleges and 12275 Non-Government colleges were reported to be functioning in the country.
- (c) The admission capacity in a college is fixed in accordance with the norms of the concerned State Government and University affiliating such colleges.
- (d) In the year 2003-04, approximately 87 lakh students were enrolled in all these affiliated colleges.

Paucity of technical experts

Will the Minister of HUMAN RESOURCE DEVELOPMENT be pleased to state:

- (a) whether it is a fact that there is paucity of technical experts against the requirement of technical industry in the country;

- (c) the average number of students to whom technical education is imparted annually?

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI MD. ALI ASHRAF FATMI): (a) to (c) The ratio of graduates in technical education to overall population is less in India compared to that in developed countries. The number of engineering degree colleges (as on 1.12.2004) approved by the All India Council for Technical Education (AICTE) is 1355 with sanctioned annual intake of about 4.59 lakhs.

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRI MD. ALI ASHRAF FATMI): (a) and (b) The Government supports expansion of management education as demand for managerial manpower is growing. The All India Council for Technical Education (AICTE) has been mandated to assure quality in management education. It has laid down strict norms and standards for establishment of new management institutes and their intake. The quality of these institutes is constantly monitored. For awareness of students, a list of approved technical institutes has been made available on the website of AICTE (www.aicte.ernet.in). AICTE also publishes notices, from time to time, in leading newspapers, cautioning all concerned to check the approval status of technical institutions before joining them.
