(b) and (c) Possibilities of purchase of ships from other countries are usually explored by shipowners. In some cases, however, information regarding availability of ships for sale to or construction for Indian shipowners in foreign countries is received by Government also. In both cases negotiations leading to contracts are conducted by the shipowners. The terms offered by the prospective seller are duly considered by the shipowner in all their implications. The type of ships and terms of purchases are subject to approval by Government.]
